

# Risk Assessment – Velcro Wall

Velcro Wall	Injury through lack of supervision.	A supervisor must be present with the velcro wall at all times.	1	5	5	None
Velcro Wall	Injury through incorrect positioning.	Do not move or try to reposition the activity under any circumstances and ensure that the anchors are in place at all times.	1	2	2	None
Velcro Wall	Choking	No food drinks or chewing gum to be allowed on or near the Activity.	1	4	4	None
Velcro Wall	Injury through 3 <sup>rd</sup> party items & 3 <sup>rd</sup> part bodies.	All shoes, glasses, jewellery, badges MUST be removed before using this Activity. Always ensure that the area surrounding the Activity is not overcrowded.	1	5	5	None
Velcro Wall	Danger of fire.	No smoking or barbecues near the Activity at any time.	1	5	5	None
Velcro Wall	Emergency.	In the event that someone is seriously injured, DO NOT move the individual, leave the activity switched on and dial 999 immediately.	1	5	5	None

L=Likelihood S=Severity L\*S= Risk 1=Low 5=High

Risk is worked out using numbers 1 - 5. The likelihood is given a number and this is multiplied by the number given to the severity of the risk.

The result = the risk factor. This generic risk assessment is brief and we have our own individual assessments for each individual risk, 25 being the worst possible outcome, any item reaching 25 would give serious cause for concern & we would not be able to erect the unit. It is recommended that clients undertake their own risk assessment to suit their requirements.
